- 1. The defendant Moves, pursuant to G.L. C. 272 s. 99, 18 USC s. 2510et seq, Article 14 of the Massachusetts Declaration of Rights to suppress the <u>contents</u>, as defined by G.L. C. 272ss. 99, B5, the tape recording by Sgt. Sanchez of the F.P.D. of this defendant's phone conversation on 7-6-00.
- 2. The prosecution has designated that tape recording, in #1 above, as prosecution evidence.

The defendant further moves to suppress all evidence derived from the aforesaid intercepted wire communication:

As reasons therefore,

- 1. The communication was unlawfully intercepted (recorded).

Memorandum of Law

In Support of

Illegally Recorded Sanchez Call

Per G.L. C. 272 S. 99 C 1 and 99 B 4 Mass. law outlaws electronic eavesdropping without the consent of all parties.

Aticle 14 of the Mass. Declaration of Rights protects citizens from violation of their expectation to privacy via electronic eveasdropping (tape recording). See <u>Com. v. Blood</u>, 507 N.E. 2d 1029, 1034, 400Mass. 61.

"Consent by one party" to the conversation does not alter the need for a warrant by the police when recording a phone conversation. see Blood, p.1034 and 1037.

Electronic seizure by surreptitious recording is in violation of Article 14 of the Mass. Declaration of Rights. <u>Blood</u>, p. 1038. Such electronic seizure (tape recording) requires exclusion of the tape recording by Article 14 of the Mass. Declaration of Prights, <u>id</u>. The seizure (tape recording) being illegal, the fruits thereof must also be suppressed, <u>id</u>.

No testimony derived from eirther the <u>transmission</u> or recording is admissible. Therefore, no one who has listened to either the transmissions or the recordings may testify as to any thing thus heard. No evidence derived from those acts of eavesdropping may be admitted.

Illegally Recorded Sanchez Call

- 1. I am the defendant, Michael Elbery.
- 2. I am not, nor have I ever been accused of being, associated with Organized Crime.
- 3. At approximately 7:30 a.m. on 7-6-00 I received a phone call at my residence at 168 Fairfield St., Needham, Mass., from a Sgt. Hector Sanchez of the Framingham Police Dept..
- 4. During that phone conversation in #3 I was not alerted that I was being recorded nor did I receive any signal indicating I was being recorded.
- 5. After several minutes of conversation it occurred to me that Sanchez could be illegally recording our conversation.

- 6. I immediately asked Sanchez if he was recording our phone conversation.
- 7. Prior to asking about the phone being recorded I had no idea Sanchez was recording me. The thought had not entered my mind until, as #5,6, I immediately asked Sachez about a recording.
- 8. Sanchez admitted that he was recording the conversation without alerting me as the law requires.
- 9. The police have <u>altered</u> that tape recording of the above conversation in order to subdue my question to Sanchez in #6 as inaudible.
