None of the 5 heirs and owners of the house should want anything to do with Attorney James A. McLaughlin. He uses the Probate process to steal. But once again, my opinion is that McLaughlin is legally prevented from getting that License because his time has run out, as last email.

If McLaughlin gets that License the \$750,000.00 check for the house will be made out to him and then he will do more stealing and never give us a penny.
