I received an envelope delivered me, U.S. mail, from the Norfolk County Clerk's Office containing some of the docketed Court docs I had requested before they slammed the phone in my ear!

The only reason the Clerk's Office sent me those docs is because of the email I sent you complaining that you had cut me off and caused the Norfolk County Probate Clerk's Office to shut me off from any assistance, including sending me documents docketed to Estate of June Elbery at the Norfolk County Court.

I still need docket numbers #34 "Order following statement of resignation 4/29/17", #35 "Resignation of Stephen J. Hanna as Fiduciary 5/31/16", #36 "Order on Decree and Order on Petition for formal 5/31/16", #37 "Decree and Order for formal appointment of successor PRP 5/31/16", #38 "Petition for Order of Complete Settlement" and #41, "Decree and Order Of Final Settlement". Those documents should indicate the hand written clerk's notation on the first page of each document, just to be sure no one is cheating.

Also, You have not produced the Final Mass. Estate Tax Return that you took it upon yourself, over my objections, to file. The Heirs not only are entitled to that Tax Return, as a matter of law, but Demand it. I could have done that return and I was the one that had to show you Hanna's mistakes.

When you send us all the Estate documents we are entitled to, then I will sign the LPC-2 Form.
