On 10/15/92 I spoke with Linda Schlenner, 27 Fifth Avenue, Shrewsbury, telephone number 756-2307. Linda wanted to report the intimidation of a witness.

She stated that her husband, Jeffrey, works at the Winners Circle, Shrewsbury Street, Worcester. He was working on 09/28/92 and 09/29/92. At approximately 1:00 AM Michael G. Elbery, 370 Oak Street, Shrewsbury, D.O.B. 02/08/52, SS# 016-42-4787, came into the Winners Circle and went up to Jeffrey who is the bartender. Mr. Elbery was very unruly. Jeffrey served Mr. Elbery a beer. Mr. Elbery he took the beer and smashed it. The glass flew and struck some female patrons. In the bar, at this time, were Thomas King, a police officer in the

town of Westboro, who had stopped in to see Jeffrey as he as a friend of his.

After Mr. Elbery smashed his beer, he went out the front door. Tom King went out to try to calm him down and a fight ensued. Some other patrons of the Winners Circle came out. The Worcester Police arrived on the scene. In the interim, Mr. Elbery tried to pull Tom King's eye out by it's socket.

From the information I received, Michael Elbery was charged with mayhem, assault and battery and numerous other charges with the victim being Thomas King. This case is pending in the Worcester District Court.

The intimidation came in when Mr. Elbery knew how to get in touch with Jeffrey Schlener and did call him on 10/14/92 at approximately 1:11 AM. Both Jeffrey and his wife, Linda, picked up two different telephones at exactly the same time in different parts of the house. Jeffrey positively recognized the voice as that of Michael Elbery. Michael Elbery stated, Jeffrey, it's all lies. I'm going to kill you. You're going to die.

After taking this initial information, I spoke with Thomas King. He advised me that the ADA in Worcester wanted to know if there were any type of threats made as a result of this case. He then got in touch with the ADA in Worcester, Michael Salloum.

I spoke with ADA Salloum. He stated that he would like this Department to take out complaints for intimidation of a government witness, Jeffrey Schlener. With this, I had Detective Hester, who was at the Westboro District Court, obtain a warrant for Michael Elbery for intimidation of a government witness in a case in the Worcester District Court against Mr. Elbery with the victim being Thomas King.
