AMENDED MOTION TO SUPPRESS

Now comes the defendant Michael Elbery and respectfully moves this Honorable Court to order suppressed the fruits of warrantless entries and searches of his storage container numbered C341 at EZ Mini Storage on 869 Boston Turnpike in Shrewsbury on August 5, 1994 by the Shrewsbury police. The observations allegedly made as a result of said warrantless entries and searches served as the sole basis for a warrant search conducted later that day by the Shrewsbury police.

The defendant further moves that the fruits of the warrant search be suppressed since the affidavit in support thereof contained material misrepresentations without which the warrant could not have been issued or which taint the warrant and render it unsuitable.

In support of his motion the defendant says that the initial entries were warrantless and without lawful justification and that the warrant was obtained unlawfully. The police thus violated the defendant's federal constitutional rights under the Fourth and Fourteenth Amendments and his state constitutional rights under art. 14.


